Playing Kit supply policy:

Chelmsford Hockey club play in Green playing shirts, Dark Blue Shorts or Skorts and Green socks. Training kit is all Dark Blue.

All players are expected to provide their own playing/training kit and to wear club colours.

For league games playing shirts must be appropriately numbered.

N.B. Players selected for First XI squads will be supplied with a playing shirt only (which remains club property), although we advise that you have your own shirt in case of playing for lower teams at some stage.

All Club playing and training kit is ADIDAS brand supplied by Intersport Lewes, to view and order the playing and training kit ranges please follow this link:

Shirt numbers will be issued by Intersport at the point of ordering and is included with in the price of your shirt. Junior players have the option of having their name added along with their number.

All players are expected to provide any other hockey related playing kit themselves this includes, but is not limited to:

- Hockey Sticks – for new players the club holds a limited stock that can be lent for a short period whilst the player obtains their own stick.
- Shin pads and gum shields – the club strongly urges the wearing of both whenever playing hockey.
- Stick bags
- Drinks bottles
- Penalty Corner protective face masks
 - All junior players who regularly play in a defence position are strongly recommended to purchase, and bring with them, their own face masks. Whilst the club will endeavour to provide face masks for junior players, the onus is on the player (and their parent or guardian) to ensure they are properly protected at both training and matches. The club will not be held liable if a player chooses not to wear a face mask and becomes injured.
 - For adults players the club expects them to provide their own masks.

Chelmsford Hockey Club:

Goal Keeping Kit supply policy:

It is Chelmsford Hockey Clubs preference that all Senior Goal Keepers own their own equipment. On the grounds of hygiene, upkeep and to promote the best physical fit possible. We recognise that such an undertaking comes at a high cost to the player and as such have made a number of provisions outlined below to help mitigate this.

For junior keepers equipment will be provided, but the kit stays with the age group squad once the player moves up through the club.

Goalkeepers (or parent/guardian) using items of club kit are expected to look after it properly. This will include, but not be limited to, keeping it clean, drying or airing it out after use and reporting damage to the kit manager as soon as it's noticed in order for replacement/repair to take place promptly. The club expects the equipment only to be used in conjunction with activities related to Chelmsford Hockey Club.

Club kit may need to be re-issued to another keeper at short notice, hence players using club kit should be able to make the kit they are using available at Chelmer Park at short notice.

N.B. any damage to club deemed to be as a result of misuse may result in the player being billed for any repair/replacement costs.

The club has 'benchmark' kit lists for Senior and Junior goalkeepers (appendix 1) (N.B. the benchmark kit was selected through consultation with senior goal keepers from the club). If a goalkeeper using club kit wishes to acquire a different make/model then they are welcome to do so. Any difference in cost will be borne by the goalkeeper and the arrangement will be covered in writing (appendix 2).

In essence, if a goalkeeper has contributed to an item of kit beyond the benchmark lists, and if that goalkeeper leaves the club, then they can either;

1. Pay the club an amount to cover the club contributed cost or
2. Pass the item to the club who will reimburse an amount.

The amount paid to the club/by the club will be dependent on condition, age, etc. of the retained/returned item.

Due to high cost of goal keeper equipment, any player wishing to purchase their own equipment may apply for interest free financial support from the club (appendix 3).

N.B. Junior/Senior is deemed by the level being played, NOT the age of the goalkeeper.

Goalkeepers are responsible for the purchase of their own stick and smock (shirt).

If a goalkeeper using club purchased kit leaves the club then **ALL** club kit in their possession **MUST** be returned.

Goalkeepers who own and use ENTIRELY their own kit are eligible for a 50% reduction in all club fees (match and annual subscription).

Chelmsford Hockey Club:

Goal Keeping Kit 'Bench Mark' List:

- U8 to U12 –Obo Ogo level or equivalent.
- U14 to L5/M5 – Obo Ogo Ultimate / Yahoo level or equivalent

N.B. each player will be assessed on a case by case basis, taking into account their age, current playing level, likely promotion rate through the club and personal preferences.
